Delegates from New Mexico will join more than 1,800 students from across the country in Washington, D.C., June 15-21, 2026. During the trip, students will:

- Connect with peers from 44 states, building friendships that last long after the trip

VEGETATION MANAGEMENT UPDATE

Crews working to trim trees and vegetation in rights-of-way are currently in the following areas and are expected to remain there for the next few weeks.

We kindly ask for your cooperation when you see crews working to keep these areas clear. This task plays a vital role in reducing fire hazards and ensuring consistent delivery of power to members.

Please be aware that vegetation crews do not chip or remove dead limbs and brush after it is cut. They will make sure that it is not in a driveway, pathway, or creating any additional hazard. OCEC's main concern in vegetation management is powerline reliability and safety.

ENERGY EFFICIENCY TIP

With the holiday season approaching and more time spent in the kitchen, consider ways to save energy in the heart of your home. When possible, cook meals with smaller, energy efficient appliances, such as toaster ovens, slow cookers and air fryers. When using the range, match the size of the pan to the heating element. Keep range-top burners and reflectors clean so they reflect heat more efficiently. After your holiday meals are complete, load the dishwasher fully before starting the wash cycle.

WINTER DISCONNECT MORATORIUM

Protection from winter shut off begins November 15, 2025. To avoid potential disconnection of service, please contact the Human Services Department at 800-283-4465, or the appropriate tribal or pueblo entity for eligibility information for Low Income Heating Energy Assistance Program (LIHEAP).

Your service will not be disconnected from November 15, 2025, through March 15, 2026, if you meet the qualifications of LIHEAP and have no past due amounts or remain current on any settlement or installment agreement for amounts due as of November 15, 2025.

Members of New Mexico tribes or pueblos who need help with translation or with other matters may contact the commission's consumer relations division at 888-427-5772, who will contact the appropriate tribal or pueblo official for assistance.

COMMON CAUSES OF POWER OUTAGES

There is never a good time for the power to go out, but if it happens on a sunny day, you might be left wondering why. Here are the most common causes of a power outage.



High winds, snow and ice can cause tree limbs to fall on power lines. Other weather effects, like wildfires and lightning strikes, can cause major damage to equipment.



Squirrels, birds, snakes and other animals can inadvertently contact power lines, causing short circuits and disruptions to electrical supply.



Occasionally, we plan outages to perform upgrades or repairs to parts of the local grid.

ACCIDENTS

Vehicles can crash into utility poles, bringing down power lines. Construction and excavation work can also result in disruptions to underground lines.
