2023 Election Information

Three positions on the Otero County Electric Cooperative Board of Trustees are up for election. Elections will take place at the annual meeting of the members Saturday, August 5, 2023, in the Cloudcroft High School gymnasium in Cloudcroft, New Mexico.

Trustees holding positions expiring in 2023 are:

- Kenny Blazer—Southwest District
- Cheri Hass—Central District
- Bill Bird—Northeast District

Those elected for these positions will serve a three-year term ending in 2026.

Article IV, Section 3 of the Bylaws states:

SECTION 3. Nominations. Nominations for Trustees to be elected shall be by Petition signed by fifteen or more members acting together, and who are bona fide residents of the district for which the nomination is made. The Petition shall be filed not less than twenty-five (25) days or more than forty-five (45) days before the date of the Meeting of the Members in which Trustees are to be elected. Nominations for the position of Trustee from the floor, at the Annual Meeting of Members, are not allowed.

The secretary shall include with the notice of the meeting, at least ten (10) days before the date of the meeting, a statement of the number of Trustees to be elected and the names and addresses of the candidates. Notwithstanding anything contained in this SECTION, failure to comply with any of the provisions of this SECTION shall not affect in any manner whatsoever the validity of any election of Trustee.

Petition forms are available for pickup in any of OCEC's local offices in Cloudcroft, Alto or Carrizozo, or can be downloaded on www.ocec-inc.com beginning June 1, 2023. According to the dates outlined in the bylaws, petitions will only be accepted between Wednesday, June 21, 2023, and Tuesday, July 11, 2023. Completed petitions may be turned in at any OCEC office.

Preventing and Preparing for Wildfires

Wildfires can destroy homes, equipment and property and even take the lives of the professionals who are on the front lines battling the blaze to save families and homes.

Otero County Electric Cooperative encourages you to learn about prevention and prepare for dangers related to wildfires.

Whether you are burning debris, running equipment or tending a campfire-always make sure fire, sparks and embers are contained and safely extinguished.

A fire that gets near power lines can create additional hazards. Safe Electricity offers these tips:

 If you see downed power lines or other damaged electrical equipment, notify the local electric utility as soon as possible. The lines could still be live and present a fire risk.

· Downed power lines, stray wires and debris in contact with them all have the potential to deliver a fatal shock. Stay clear of fallen power lines and damaged areas that could hide hazards.

 Contact the electrical utility immediately if you see fire near transmission or distribution lines.

If a wildfire is threatening your area, tune in to local media for reports and evacuation information. Smoke limits visibility, and evacuation routes can be cut off by fire, traffic, fallen trees or power lines. Follow the instructions of local officials. If you are



Never leave a fire unattended. and make sure you completely extinguish the fire when you're done. Drench the fire with wate and stir the ashes until cold.



When burning yard waste, follow local ordinances. Avoid burning in windy conditions, and keep a shovel, water and fire retardant nearby to keep fires in check.

Tips to **Prevent Wildfires**



Never discard cigarettes, matches and smoking materials from moving vehicles, or anywhere on park grounds. Completely extinguish cigarettes before disposing of them.
